The candidate should meet the conditions set out in the Act of July 20, 2018: Law on Higher Education and Science (i.e. Journal of Laws of 2018, item 1668, as amended). Working and remuneration conditions according to the applicable Act.

Requirements:

- PhD in chemistry,
- scientific achievements documented by publications from the JCR list,
- proven knowledge of English at a level of at least B2 or its equivalent,
- good knowledge of materials chemistry, in particular in the field of synthesis of coordination and organometallic compounds,
- practical knowledge of spectroscopic, electrochemical and / or crystallographic techniques,
- experience in working in research projects, including work in international teams
- ability to work in a team, communicativeness and diligence.

A candidate may be a person who meets the following requirements set out in the Act on Higher Education: has the qualifications specified in the Act, has full legal capacity, has not been punished by a final court judgment for an intentional crime, and enjoys full public rights.
